Resolutions are not laws like ordinances but are guidelines or acknowledgements. They are often used to recognize people, issue bonds, and approve fees, budgets, pay plans, strategic plans, interlocal agreements, etc. Use the <u>Resolution Search Document</u> and type key words to find a specific resolution.

The older resolutions are grouped and bookmarked and these files tend to be large and may take some time to open. Redevelopment Agency and Municipal Building Authority Resolutions are not included.
