# Sundance 2021 Load In/Out Permits

# When will I need this permit?

You will need a Special Use Load In/Out permit if you need to load-in/ out of a Main Street Core Area venue, if you are required to provide crowd control/mitigation, park a Satellite Truck, need to store a POD, or require a lift/ boom AND the activity requires the use of public parking spaces.

# **Quick Start Guide:**

- Applications will be accepted starting December 7<sup>th</sup>, 2021.
- Site Map is required. Example: Google street view with parking spaces <u>clearly marked</u>. (Aerial view will not accepted).
- 72 hours (3 business days) is required to review a p p l i c a t i o n .
- No requests will be reviewed/granted during Martin Luther King Jr. holiday January 18th, 2021.

# FAQ

#### Q. Is parking allowed on Main Street during Sundance?

A. No. Main Street is a drop-and-load zone from Tuesday, January 26, 2021 through Sunday, January 03, 2021 Deliveries and load-in/ out(s) of venues, require a permit.

#### Q. What is a Special Use Load In/Out permit required for?

- A. The Special Use of Load In/Out permit is required for activity during with Sundance Film Festival event time period that involves the use of public parking spaces. This permit is required for the following activities:
  - Venue Load-in/Load-out requests
  - Moving Trucks/ Vans/ Trailers
  - Satellite Trucks
  - Lifts/ Booms
  - Crowd Control/ Mitigation
  - PODS/ Storage/ Etc.

#### Q. What are the types of Permits?

A. Red Permit: for large-scale loading operations (only permitted between <u>4am-10am</u> on designated days). First opportunity for load-out with a RED loading permit will be Tuesday (Day 6) after the start of the Festival. NO LOAD-OUT permitted during the first Saturday, Sunday, or Monday of the Festival.

**Green Permit:** for smaller loading operations such as catering, food/beverage or linen service (15 minute maximum, allowed during day & evening), vehicle may not be larger than 15' in length.

**Blue Permit:** for the active loading of musical instruments, sound equipment and related materials such as amplifiers, microphones and cords (permitted during the day/evening but with specific parameters on location and timing)

# Q. I rented out my Main Street business for Sundance, I need to move my stuff out; do I need a permit?

A. Yes. A Special Use Load In/Out permit is required for any activity on Main Street associated with Sundance Film Festival that involves the use of public parking spaces.

# Q. How much does a permit cost?

A. Cost is \$50.00 per space (22 feet) per day, plus a \$20.00 application fee.

# Q. Where is this permit required?

- A. The Special Use Load In/Out permit is required for extended parking in public parking spaces/lots/garages, which include Main Street, Swede Alley, China Bridge Parking Structure, Park Avenue, Heber Avenue and the following lots:
  - Flag Pole Lot
  - Brew Pub Lot
  - Bob Wells/ Historic Wall Lot
  - Sandridge Lots (Upper and Lower)
  - North Marsac Lot

# Q. How do I apply for this permit?

A. You can email your application <u>starting December 4, 2021</u> to <u>parking permits@ parkcity.org</u> or apply in person, by appointment, at 1053 Iron Horse Drive, Park City, UT 84060. (Note: Please allow 72-hours to process your application.) or, call 435-615-5301.

# Q. How do I pay for this permit?

A. The following forms of payment are accepted: Cash, check or Visa, MasterCard, American Express and Discover cards.

# Q. Where do I pick-up my permit?

Permits can be picked up by appointment at the Public Works Building, located at 1053 Iron Horse Drive, Park City,
UT 84060. Hours of operation are M – F, 8:00 AM – 5:00 PM MST. For appointment/directions please call 435-615-5301.

# Q. Can I load-in or load-out if my venue is located on a red curb/no parking zone?

A. No. Red Curbs and no parking zones are in place for public safety reasons.

# Q. What if I'm just making a delivery?

A. Main Street is designated Drop-and-Load during Sundance (driver must remain with vehicle). Deliveries will require a Special Use Load In/Out permit (see above).

# Q. Why can't I load-in or load-out during Martin Luther King Jr. Holiday weekend?

A. In accordance with Park City Municipal's licensing code, Sundance activity will be restricted over the holiday weekend.

# Q. Does the City barricade/ hold parking spaces when we purchase this permit?

A. No. Applicants with an approved permit are solely responsible for barricading spaces they have reserved. Parking is restricted on Main Street from 2am – 6am. We recommend barricading your spaces as close to 6:00am on the day(s) of your permit to ensure availability.

#### Q. What can I use to barricade the spaces I have reserved?

A. Type 2 barricades or Orange traffic cones (18 inches tall) are acceptable. Caution tape between barricades is highly recommended.

#### Q. Where can I rent barricades?

A. There are several traffic supply companies based in Salt Lake City. Enter 'traffic supply' in your browser to find suppliers.

#### Q. Any special requirements for moving trucks/ box trucks?

- A. Yes. For security reasons, we require box trucks and delivery vehicles to be attended at all times. This permit allows active loading and unloading ONLY. Parking is not allowed. Contents must be visible. Flashers are required. When delivery is complete, and the truck is closed up, it must vacate the Main Street area. This will be enforced by Park City Police Department and Park City Parking Enforcement.
- Q. I have a lift/ boom, which will be on the sidewalk; do I still need a Special Load In/Out permit?
- A. Yes. Also, applicants who require the use of the sidewalk or street, within the public right -of- way, must receive authorization and a release of liability from the City. A separate 'Sidewalk Closure' permit is required and can be obtained through the Engineering Department (435 -615- 5056).
