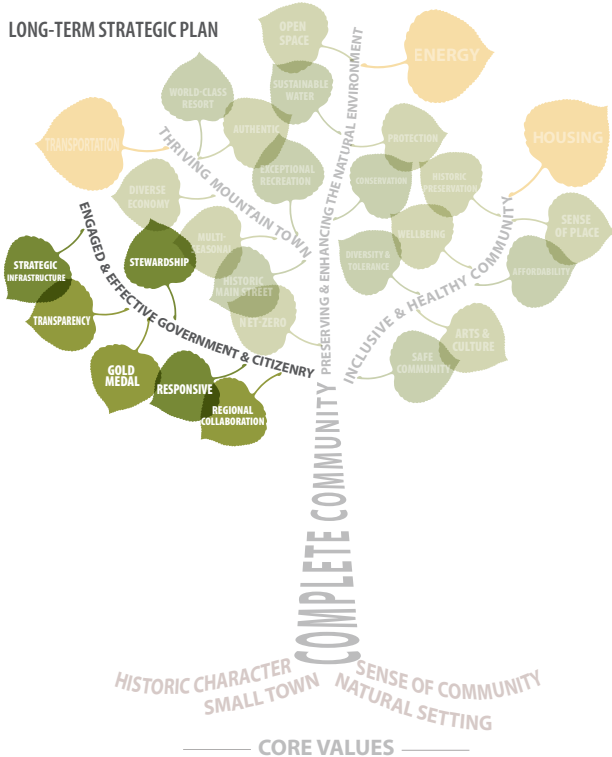


Our Value Statement:

- Meet with Summit Land Conservancy, Utah Open Lands, Basin Recreation, Mountain Trails and other private landowners on open space issues
- Mental wellness regional financial support
