NARRATIVE DESCRIPTION OF PROPERTY

481 Woodside is a T/L cottage that has undergone significant changes. The T/L cottage, also known as a cross-wing, is one of the main three house types built during the historic Park City mining era. A street level garage has been built in front of and below the main house and the house appears to have been expanded to the rear, with the shed roof of the addition being visible from the front of the house. The cross gable roof is sheathed with composition shingles and the walls are clad with drop-novelty wood siding. There are three one-over-one sash windows in the projecting bay on the front gable, one on each side. In the porch area, there appears to be a casement type window with an upper transom. A small casement window is present in the dormer on the stem wing. The porch is covered by a shed extension of the main roof, which is supported

by square wood posts. There is a large deck area on the roof of the garage that appears to be having its balustrade altered in the most recent images. The site is sloped significantly and a wood stair leads from the sidewalk up to the porch area. A stone retaining wall begins next to the stair and follows the sidewalk away from the driveway. Although the overall form remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:
(Briefly describe those characteristics by which this property may be considered historically significant.)

This house was built while the property was under the ownership of the Park City Townsite Corporation, and was likely used to house workers originally. Ownership was transferred to Hattie Y Williamson in 1898. A city directory shows a Hattie Y Williamson residing in Salt Lake City in 1902, so it is possible that she did not live at the property. The next owner was Luella Barker, who obtained the property in 1907.

A 1900 census shows Luella Barker living with her husband Charles, and niece Amanda, on Woodside Ave, but in a different house. Her husband was a "stationery engineer." No record of their family is found past 1900. They only owned the house until 1908, when it was transferred to George Williams.

George Williams was an engineer with the railroad. He lived at the house with his wife Ester, and their two children. He appears on the 1910 census, but no other information regarding him or his family could be found. The property was transferred to R H Billings, who quickly sold it to George S Krueger.

George Krueger owned the house during the 1920 census, but the house does not appear on it, indicating that it may have been vacant at that time. He is shown on that census as living in Empire Canyon with his wife Beulah and their son Paul. He was a superintendent with the Judge, Daly, and Daly West mines. The house was sold to Mark Snow in 1923.

Mark Snow is found on the 1920 census as living on Woodside Avenue. It may be that he lived in this house, but no house number is given on the census. The entry's position on the census does make it likely that it was this house. He was a mining engineer, and lived at the house with his wife Minnie and their daughter

Helen. The property was transferred to George Polychronis in 1926, who sold it two months later to Victor Peldan.

Victor Peldan, also known as John V Peldan, lived on the property during the 1930 census with his wife Anna, and their two daughters. He was born in Michigan, and worked as a miner in Park City. No other information is available on him or his family. The house was sold by his wife Anna in 1940 to Clarence Welch.

Clarence Welch was a miner in Park City, and had lived there since at least 1930. Neither he nor the house appears on the 1940 census. He died in 1955, and his wife Della lived until 1989. The property has changed hands several times since Della Welch sold it in 1959, and is currently owned by Christopher and Jennifer Dimeo.
