## NARRATIVE DESCRIPTION OF PROPERTY

505 Woodside is a cross-wing variant that has had several additions. The cross-wing, also known as a T/L cottage, is one of the main three house types built during the historic Park City mining era. There have been several rear additions to the house made since 1968 and the front porch area has been expanded since the c. 1940 tax photo. The cross gable roof is sheathed with standing seam metal, as is the rear addition. The walls are clad with drop-novelty wood siding, which appears to be original, and with vertical wood cladding on the lower area on the right side of the primary façade. The windows are primarily one-over-one single hung sash type windows, with a pair present on the stem wing section of the house and three under the porch, a paired set and a single, both closely resembling the original. The porch area is covered by a shed extension of the main roof, which is supported by square wood posts. The deck extends slightly past the covered area of the porch and has a simple wood balustrade, a change since the 1995 photo where a lathe turned wood balustrade is seen. The entire porch was reconstructed sometime before 1995 with the posts and deck being

rebuilt again after that time. The site slopes up from the road and several stone retaining walls are present on the property. Although the overall form remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:

This house was likely built while under the ownership of E.L. Heal, a miner and rancher in the area. He lived in Park City with his wife Mollie and two sons, and is noted on the 1900 census, though it is unknown if they lived in this house due to the lack of addresses on that census. He sold the property to William Sanders in 1898

There is no record of William Sanders living in Park City during the time that he owned the house, thus it is likely that it was rented during his ownership. He sold the property in 1902 to Charles Loving, of whom there is also no record.

Patrick Mannin was the next owner, and sold the house to Mary Stout. Mary Stout, or Mary J McFalls, lived on Woodside Avenue during the 1900 census with her husband Charles McFalls, and their four children. Charles was a carpenter, and died in 1900. The house was transferred to James Hamilton in 1906, and then to D. H. Haran on the same day.

Daniel H Haran lived at the house during the 1910 census, with his wife Elizabeth, and their eight children. He was a merchant, and worked in retail. He was born in Ireland, and came to the U.S. in 1879. He died in 1930, but the property passed on to his son Leo in 1937. The house was rented out, and was occupied by Oran Baurne and his family during the 1940 census. Oran was born in Salt Lake City, and worked as an operator in an electric power plant.

Leo Haran sold the property in 1965, and it has had a variety of owners since, currently being owned by Woodside Development LLC.








Figure 1: Aerial view showing the location of 505 Woodside Avenue. (ESRI 2020)


