NARRATIVE DESCRIPTION OF PROPERTY

543 Woodside is a cross-wing type house that has undergone significant changes. The cross-wing, also known as a T/L cottage, is one of the main three house types built during the historic Park City mining era. The projecting bay present on both the main and lower level seen in the c. 1940 tax photo has been altered so only the lower projecting bay is present. A rear addition was built at some point after the 1968 tax card. The cross gable roof is sheathed with composition shingles. The house is clad with drop-novelty siding which appears to be original with coursed stone on the lower level. Although a previous site information form notes

that the fish-scale shingles in the gable may not be original, they appear to have been present when the projecting bay was still extant and appear to be original. There was a group of four windows in the front gable end where a projecting bay was previously which replaced by a pair of one-over-one double hung sash windows sometime between 2013 and 2020 when the lower bay was extended to the second floor. Other windows include a pair of one-over-one double hung sash windows in the lower part of the bay and another pair with a horizontal picture window in the porch area. The door is a wood frame and panel door with an upper light. The porch is incorporated under the roof with square wood posts. A simple wooden balustrade surrounds the porch area and leads down the stairs to a lower deck or porch area, which has stairs leading to the sidewalk. There is mention of a bunk house and small shed on tax cards, but these are not visible in present images. The site is sloped steeply upward from the road. Although the overall form remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:

This house was built while under the ownership of Edward Cook, though it is not known if he lived in the house. The next owner was William Tretheway, who bought the house in 1892. William Tretheway was a mining foreman who was born in England, and emigrated to the U.S. in 1883. He and his family appear on the 1900 census, living in a house on Woodside, though it is unknown if it was this house, due to the lack of addresses on that census. They sold the house in 1910 to Charles Martin.

The house was not on the 1910 or 1920 censuses, indicating that it was likely vacant at that time. The house came under the ownership of the county, and was then sold to W.D. Turner in 1926. William Turner was a farmer who lived in Kamas during the 1920 census. It would appear that he did not live in the house, as it was rented out during the 1930 census to Lyle Cossey and his family. Lyle was a barber who grew up in Park City, and lived in the house with his wife Laurinda, and their daughter Mildred. The house was likely foreclosed on in 1938, and the property went to auction, being bought by the Home Owners Loan Corporation. The house was rented out during the 1940 census, and was occupied by Oscar Clegg, his wife Della, and their three sons. Oscar Clegg was a trapper in the area. The house was sold in 1945 to Rex Leatham.

The property has changes hands many times since the historic period, and is currently owned by Smaxski, LLC.










Figure 1: Aerial view showing the location of 543 Woodside Avenue. (ESRI 2020)
