NARRATIVE DESCRIPTION OF PROPERTY

The house at 627 Woodside is a variation on a cross-wing type house that has undergone several modifications. The cross-wing, also known as a T/L cottage, is one of the main three types of houses built during the historic Park City mining era. The house appears to have been lifted to construct a basement level addition. The garage at the street level was present during the c. 1940 tax photo, but it is unknown when it was added. The half-hexagon bay on the front façade was originally an arced projection with five windows. A gambrel roof addition was constructed after 1968. The cross gable roof is sheathed with composition

shingles. The walls are clad with drop-novelty siding and the lower section with vertical board siding. The garage is clad with stone veneer. The windows are mostly casement windows, with a set in the porch area, one on each side of the bay and another set below the bay. The door is a wood frame and panel door that has two upper lights. The porch is covered by a section of the roof which is supported by square wood posts with a simple wood railing. There is a deck area on top of the garage that has a wood balustrade. A stair starting at the sidewalk leads to the deck area and turns up to the porch. Although the overall form remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:

The house is present on the 1889 Sanborn map, and it is unknown when before that it was built. It was owned by the Park City Townsite Corporation, and if it was occupied, it was likely used to house workers. The first individual to own the property was Joseph Busby, who purchased it in 1889. There is no record of a Joseph Busby living in Park City, but there is census information for a Joseph Busby in Salt Lake City, so it may be the case that he rented the home out. The next owner was Charles Street, who purchased it in 1890. Charles Street is found on the 1880 census living in Park City with his wife Anna and their four children. He worked as an assayer, but nothing else is known of him. The next owner of the home was William O'Connell. No information regarding a William O'Connell living in Park City could be found.

The property later came in the hands of James Berry, and was sold to Patrick Mannin in 1905. It was sold in the next year to Mary McFalls, who owned several properties on Woodside Avenue. After a tax sale, James Berry bought the property again, and lived there with his wife Rhoda and their family during the 1920 census. He worked as an acid drainage operator for a mine at that time. They continued to live there during the 1930 census, when James worked as a tram operator. James died in 1932. His wife Rhoda lived until 1965, and the property was passed down to her daughter Thelma. The property has traded hands several times since then and is currently owned by Joyce Solberg.







Figure 1: Aerial view showing the location of 627 Woodside Avenue. (ESRI 2020)



James L. Berry Called

With the ushering in of Memorial Day the spirit of a real old timer of Park City, and an esteemed citizen of this community for the past fifty-one years, passed out to God, who gave it. James L. Berry, who since 1881, was prominent in civic and business affails, was suddenly summoned by Death early last Monday morning, following a three weeks illness with heart trouble. Previous to this attack, deceased passed through a severe illness, from which he never re-covered his strength, and was gradually failing when shicken with his fail ill-nues.

While his passing on was not unex-ported, the news of his death was re-ceived with sincere regret—and to his sorrowing wife and family, sincere sym-pathy is extended in their hour of bereavement.

pathy is extended in their hour of beresvement. Mr. Berry was bon in Heauvalton. New York, November 11, 1861. He came to Park City in 1881. He was first employed at the old Ontario as firemen, in the days of the big Oornish pump at that property. For several years following he with his brokher 2d, conducted a large blackmuth shop in this City-and were the leading blackmiths. He then engaged in the livery business, which he follow-ed until he accepted a position with the Silver King Coalition Mines company, in cherge of the aerial tranway, and held that position for niteteen years. At the time of the disastrous Park City fire in 1898, Mr. Berry beld the position of fire chief of the city, and long before that and up to the time of his death. Was an active member of the local fire department.
