NARRATIVE DESCRIPTION OF PROPERTY

(Briefly describe the property and its setting. 1002 Woodside is a T/L cottage that has undergone significant changes. The T/L cottage, also known as a cross-wing, is one of the main three house types built during the historic Park City mining era. A large rear addition has been built onto the house. The porch has also been altered from the large porch that filled the L of the house, which was enclosed and with a narrow entry porch built in front of it. The cross gable roof is sheathed with standing seam metal, as is the roof of the addition. The walls are clad with wooden clapboard siding and a stone veneer where the site slopes down away from the road. There is a group of three multipane casement windows in the front gable end. A single multi-pane casement window sits on either side of the entry porch area. The door is wood and has an oval upper lite. The porch roof is gabled and is supported

by square wood posts. The site has many large trees on it that obscure the view of the front of the house, while the rear has very little landscaping. Although the form remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:

(Briefly describe those characteristics by which this property may be considered historically significant.)

This house was built between 1889 and 1900, judging from the Sanborn Insurance maps. The property was acquired from the Park City Townsite Corporation by Joseph Durkin sometime prior to 1896. It is likely that the house was built while under the ownership of Joseph Durkin.

Joseph Durkin appears on the 1900 census, living on Prospect Street at that time. He was a miner and lived in Park City with his wife Mary and their six children. He was born in Canada and emigrated to the U.S. in 1859. He sold the property in two parts, one in 1896 to Ruth Handey, and the other in 1905, to Edwin Nichols. As Joseph Durkin died in 1902, it is likely the latter sale was performed by his wife.

No information could be found on Ruth Handey, but Edwin Nichols lived in the Salt Lake and Utah Valley Area for much of the late 19th and early 20th centuries. He was married in 1888 in Park City, but there is no record of him ever having lived there. Censuses state that he worked as a miner. He sold the property in 1906 to John Mills.

John Mills was recorded on the 1910 census as living at the house that was neighboring this house, 1006 Woodside Avenue. That house was demolished between 1907 and 1929, and since that time the two lots have been sold together. He worked as a miner, and lived in Park City with his wife Sadie and their seven children.

Each part of the current property somehow came under the ownership of the county, and were sold to James Sullivan, one in 1916 and the other in 1920. James Sullivan appears on the 1920 census, living in another house in Park City, 1007 Park Avenue. We worked as a water master for the city, and lived there with his wife Teresa and their three children. The property came under the ownership of the county again by 1927, and was purchased by Leonard Smith in 1929. He is listed as living at 1002 Park Avenue in the 1930 census, but the 1929 Sanborn map does not show a house there, and it is likely that there was an error made and he was

in fact living at this house. He worked as an electrician for a mine, and lived at the house with his wife Gladys and their four daughters. He sold the house in 1935 to William Carpenter.

William Carpenter lived in the house with his wife Emeline, and their three sons. He worked as a compressor operator for a mining company. The house stayed under the ownership of the Carpenter family until 1972. It is currently owned by John R. and Constance Desha.









Figure 1: Aerial view showing the location of 1002 Woodside Avenue. (ESRI 2020)
