#### NARRATIVE DESCRIPTION OF PROPERTY

1147 Woodside is a cross-wing type house that has undergone significant modifications. The cross-wing, also known as a T/L cottage, is one of the main three house types built during the historic Park City mining era. The major formal changes made to this house include a large rear addition that was built in 1962 and a shed dormer added to the north side of the front gable sometime before 1995. The roof is complex, appearing to be a combination between a cross-wing roof, and a hipped roof, with the hipped area showing in the L of the cross gable. The roof is sheathed with composition shingles and the brick chimney is still intact. The house is clad with wooden lap siding, though images show that it originally had drop siding, and the tax card states that it also had aluminum siding at one point. The windows on the primary façade are mostly one-over-one double hung windows, with one pair in the front gable end and another pair in the porch

area. Though some of the windows have been changed over time, they have been restored to match the original. A small casement window sits in the upper front gable. The porch is covered by a shed roof, which is supported by lathe turned wood posts. The foundation is concrete, and has been since at least 1958. Although the form remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:

This house was built sometime before 1900, though it is difficult to determine exactly when because the 1889 Sanborn map did not extend this far. It was first owned by the Park City Townsite Corporation, and the first individual to own it was Martin Prisk, who purchased the house in 1900.

Martin Prisk appears on the 1900 census living on Woodside Avenue, though it is not known if it is this house, due to the lack of addresses on that census. He lived there with his wife Mary, their son, and their daughterin-law. He worked as a machinist for the Marsac mining company. He and his family moved away from Park City sometime shortly after the census was taken. They sold the house in 1900 to Edwin Young.

Edwin Young appears on the 1900 census, living on Park Avenue with his wife Nancy at that time. His brother and sister in law also lived with them there. He worked as a teamster, but not much else is known of him. They sold the house in 1904 to George Robinson.

George Robinson lived in the house during the 1910 census, with his wife Mary and their three children. He worked as an engineer for a concentrating mill; one of his sons also worked at a concentrating mill. They sold the house to William Gardner in 1915.

William Gardner appears on the 1910 census, living in a house on Norfolk Avenue at that time. He lived there with his wife Cora, and their daughter Delta. He worked as a painter and had his own shop. It is unknown if he ever lived in this house, as no census occurred during his ownership, and no records stating such could be found. He transferred the property to his son Alexander in 1918.

Alexander Gardner lived on Park Avenue during the 1920 census. It is unknown if he rented this house out ever, but it does not appear on that same census, indicating that it was vacant at that time. Alexander worked as a car inspector for the rail road, and lived on Park Avenue with his wife Etta and their three children. They sold the house in 1918 to Carrie Stonebraker.

George and Carrie Stonebraker lived at the house during the 1930 census with their three children. George was a car salesman and was at one point the motor inspector for Park City. The family continued to live there during the 1940 census, at which point George was working for the WPA. They sold the house in 1949 to Spencer Young. The house has had several owners since that time and is currently owned by David Belz.





Figure 1: Aerial view showing the location of 1147 Woodside Avenue. (ESRI 2020)


