## NARRATIVE DESCRIPTION OF PROPERTY

1323 Park is a bungalow type house that has not had any major modifications, but has undergone quite a few material alterations. While the bungalow was not one of the three main house types built during the historic Park City mining era, it was still common to that time period. The gable roof is sheathed with composition shingles. The walls are clad with horizontal aluminum siding, with vertical siding in the gable. Stone veneer covers the foundation area. The windows and doors have undergone the most alteration. Starting at the top, in the c. 1940 tax photo, a six pane window was present in the gable but has been replaced with a large gable vent. The window on the right

side of the façade, currently a large fixed pane window, used to be a central pane window flanked by two narrower panes. What appears to be a sliding window in the porch area in the c. 1940 tax photo has been replaced with two one-over-one double hung sash windows. The door on the wall facing the street has been removed, with the door facing to the side becoming the main entry for the home. The porch area has also been altered significantly; the half wall surrounding the porch was replaced by a wood railing and the columns supporting the roof has been modified to be much larger and have a stone veneer similar to the foundation of the house. The site is largely the same, except for a planter box clad with the same stone veneer as the foundation. The cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:

(Briefly describe those characteristics by which this property may be considered historically significant.)

Though a structure appears on this lot on the 1907 Sanborn Insurance map, it appears that it was demolished to make room for the current house, which differs in size, shape, and location on the lot. Information from a previous Historic Site Form indicates that it was built around 1914, but this is not confirmed. The lot was owned by the Ontario Silver Mining Company initially, and the title history states that it was not sold to an individual until 1935. The census records disagree, and show owners of the house as early as 1930. It was a common practice in early Park City for lots to be sold off the books and recorded at a later date; this is probably the case in this situation.

The 1930 census states that the house was owned and occupied by Thomas and Lillie Lawery. Thomas was a carpenter in the house building industry. No other information could be found on them. The title history shows that the property was in the possession of Norman Smith by 1935.

Norman Smith appears on the 1940 census, living in this house with his wife Leona and their three children. He worked as a truck driver and Leona helped her mother, Margaret Clark, who owned and operated the Park City Miner's Hospital. They moved from Park City in 1942, though the property remained under their ownership until 1946. It is currently owned by Cecil R. Bunnell.







