## DEAR PARK CITY NEIGHBORS,

Last August, we saw a robust integrated response from local, County, State, and Federal resources for the 2021 Parley's Canyon Fire. Our community benefitted from available resources and great teamwork at all levels, and the monsoonal rains blessed us, but the short version is we were lucky.

That is not the case for other areas throughout the western U.S. The jet stream and atmospheric conditions last summer brought us smoky and hazy conditions from large fires to our north and west. Aside from sending firefighters and equipment out of state, however, few recourses are available at the local level to combat wildfires occurring in California, Idaho, or Oregon.

Because we live in the Wildland-Urban Interface (WUI), the natural hazard posing the most likely and most dangerous threat to our community is wildfire. A wildfire impacting our resorts, trails, businesses, and homes would be devastating in physical damages and terms of long-lasting economic impacts. This hazard constitutes a risk implicitly accepted by choosing to live in the WUI.

We will not easily stop a catastrophic fire once it gets going, but our efforts are geared towards mitigating the severity and likelihood of fire devastating our properties. Quite frankly, no one should be comfortable that a mitigation plan will stop a fire by itself without conducting work on their property to help reduce the threat to their own home, neighbors, and community - it takes a village.

We have made significant inroads by leading collaborative efforts with private, public, and non-governmental organizations regarding wildfire fuel reduction in Park City and Summit County – and your homeowners' association or neighborhood can help. As the insurance industry begins to shed wildfire risk exposure by refusing to insure high-risk areas after several highimpact fires, we are reminded that insurance alone is not the answer. There is a lot to do, and we need the community at large engaged in creating defensible space around their properties and hardening their homes against wildfire.

Inside this newsletter, you'll find links to resources to protect your home and family, fire-adapted communities, updates on wildfire mitigation efforts to reduce the risk of wildfire, and upcoming local educational events. There are measures you can implement now in and around your home to help reduce the wildfire risk and protect yourself, your family, your property, your neighbors, and your community. Of these measures, being prepared is the #1 most important. As the saying goes, luck favors the prepared.

Thank you for being part of the solution. We hope you find this information helpful. Wishing you a safe, healthy, and happy summer!

To proactively reduce the wildfire risk to our community, the City is actively engaged in strategic mitigation efforts with local partners and agencies that include:


- Coordinating with Summit County to update the 2016 Pre-Disaster Mitigation Plan;
- space and firewise plantings;
- Becoming certified as a Firewise Community;
- mitigation work within City limits;
- Creating a Citywide Evacuation Plan;
- Enacting open flames and fireworks restrictions;
- Finalizing a Forestry Plan with a revitalized Forestry Advisory Board;
- Hosting educational events through the Living with Wildfire Series;
- efforts with area landowners;

- Exploring the adoption of more restrictive WUI building codes within City boundaries;

## FAMILY EMERGENCY TOOLKIT

Early summer is a good time to make sure your family emergency kits are prepared and easy to access. Disasters can strike quickly and without warning. Waiting until the last minute to plan your evacuation or to stock up on emergency supplies is not a good plan. In the event of a disaster, there will likely not be enough emergency responders to go around. It may take 3-7 days or even more for help to arrive so we need your help in caring for your family, your neighborhood, and your business. Be prepared, build a kit!

#### **100-HOUR EMERGENCY SUPPLY KIT**

Contents should address the following areas and contain sufficient items to sustain each member of your household for up to 100 hours:

1) Shelter, Clothing,	7) Communication
& Fire	8) Safety & Security
2) Water	9) Tools & Personal Items
3) Food	10) Cooking
4) Hygiene & Sanitation	11) Important Documents
5) Light & Power	& Money
6) First Aid	12) Transportation
