#### NARRATIVE DESCRIPTION OF PROPERTY

501 Woodside is a T/L cottage that has undergone various alterations and additions. The T/L cottage, also known as a cross-wing, is one of the main three house types built during the historic Park City mining era. The house has been lifted to make room for a lower basement level and garage. A large rear addition has also been built and is visible from the front of the house. The cross gable roof is sheathed with composition shingles, as is the complex roof of the addition. The walls of the house are clad with drop-novelty wood siding, and the lower level with stone veneer. The windows are different than what is shown in the 1995 photo, but have possibly been altered to be more aligned with the original of the house. A pair of one-overone sash windows sits in the front gable end and another of the same type of window sits left of the door in the porch area. The door is a frame and panel door that has a large upper light. The porch is covered by a shed extension of the main roof, which is supported by a square wood post. The lower level has a wood garage door and a door that leads into the house. As there is no stairway leading up to the porch, it seems

this is the primary front door. The site is formally landscaped and has a few stone retaining walls. Although the overall form remains legible, the cumulative formal and material changes have diminished its historic value.

This house was built while the property was under the ownership of the Park City Townsite Corporation, and it appears on the 1889 Sanborn map. It was purchased by Mary J Stout in 1890.

Mary Stout, or Mary J McFalls, lived on Woodside Avenue during the 1900 census with her husband Charles McFalls, and their four children. Charles was a carpenter, and died in 1900. Mary did not live in the house during the 1920 census, and the house does not appear anywhere on that census, indicating that it was vacant at that time. Mary died in 1930, and the property was passed on to Thomas Paull.

Thomas Paull was a local grocer, and it is unknown what his connection to Mary McFalls was. There is no indication that he ever lived at the property.

The 1930 census indicates that there was a rear part of the property which was occupied by Bert Aubrey and his family, and the front part occupied by William Jones and his wife. The census states that the property was owned by Bert Aubrey, but information from the title search disagrees with this, stating that he did not receive the property until 1937. Bert Aubrey worked as a laborer in a concentrating mine, and lived at the property with his wife and daughter. Bert and his family continued to live in the rear of the property, while the front property was rented out during the 1940 census by Wilford Johnson, his wife Thelma, and their two sons. Bert sold the property in 1946 to Edna Carpenter, but lived in Park City until his death in 1951.

The property has traded hands many times since the historic period, and is currently owned by Ivan Knauer and Margaret Sheehan.










Figure 1: Aerial view showing the location of 501 Woodside Avenue. (ESRI 2020)


