1. QUESTION

Our firm does not offer all the services listed in the Scope. Is the intent that we submit a proposal that responds to the categories we do specialize in, or would PCMC prefer we form a team that offers all the services listed in the Scope?

Successful respondents must be capable of assisting PCMC with developing highest and best use scenarios for the various properties owned by the City. Therefore, it is the expectation of PCMS that the prime consultant be a Planning, Engineering, or Landscape Architecture firm with access to transportation planning and real estate consulting professionals. Subconsultant and teaming agreements will be accepted. If the prime chooses to team or engage subconsultants, then they must follow the submittal guidelines outlined in Section 3.0 of this solicitation.

2. **QUESTION**

Do respondents need to address all the elements under Section 2.0, scope of services? Or does the City intend to select consultants for the pool that have specialized expertise in some categories but not all?
